The proceedings will be conducted in Turkish; however, paper presentations may also be delivered in English, Russian, Azerbaijani, Uzbek, and Kazakh. The deadline for the submission of abstracts is **March 17, 2025**.

Abstracts must be composed of a length ranging from 400 to 500 words and should incorporate a minimum of five keywords. Submissions are to be directed to the email address isalaj@balikesir.edu.tr. Additionally, the participant's name, title, contact information, and ORCID code must be clearly indicated with an asterisk (*) footnote within the abstract text.

The symposium meets the Academic Incentive and Interuniversity Council (ÜAK) Associate Professorship Criteria.

ABSTRACT AND FULL-TEXT GUIDELINES

1. Abstracts must be between 400 and 500 words and should include the title, methodology, purpose, main ideas, and results of the paper within the symposium theme. They should also cover possible topics, written in text format, that will be discussed in the full text. Additionally, abstracts must be prepared in English as well as in the language preferred by the paper owner and should include five keywords.
2. Full papers should be prepared in one of the symposium languages: Turkish, English, Russian, Azerbaijani, Uzbek, or Kazakh Turkish. The title and abstract of each paper should also be prepared in English.
3. A minimum of five keywords (in the language of the paper and in English) should be included beneath the abstract.
4. Abstracts and full texts of papers must align with the symposium themes and establish a connection between agriculture, the natural environment, and law. Otherwise, the submitted papers will not be accepted for the symposium.
5. Abstracts and full texts of the paper should be written on A4 (210×297 mm) paper, with 1.5 spacing, justified alignment, and in 12-point Times New Roman font.
6. The margins should be set to 4 cm on the left, 2 cm on the right, and 3 cm on the top and bottom.
7. The title of the text should be written in single spacing, centered, in 14-point bold font, all capital letters, using Times New Roman. Titles (except for the Introduction and Conclusion) should be arranged according to the numbering format.
8. Directly beneath the title, on the right side, an asterisk footnote should be placed next to the author(s) name and surname, and the author(s) title, institution, contact information (phone and email), and ORCID number should be provided.
9. The full text of the paper should not exceed 20 pages, including tables, figures, the abstract, and references, following the specified features above.
10. The Classical footnote method (Chicago Footnote-Reference System) should be used for references.
